

**District of Columbia Bar
Board of Governors Meeting
July 12, 2022**

**Call to Order

Bar Conference, including the Celebration of Leadership and the Presidents Reception. She also shared her three main initiatives as the new D.C. Bar President: (1) to continue the Bar's long-standing support for access to justice and pro bono work; (2) to foster an inclusive environment that welcomes and values the unique talents and contributions of our diverse membership by promoting leadership and mentoring opportunities for women and diverse attorneys, and (3) to help our D.C. Bar Communities and voluntary bar associations grow and thrive by increasing D.C. Bar member engagement with these groups.

**CEO's Report

CEO Spagnoletti presented his report. He noted that the D.C. Bar continues to operate on a hybrid basis with more in-person programs and activities expected to take place in the fall. He introduced Meredith Janssen, the new Marketing and Communications director and also recognized the Bar's Human Resources staff for their efforts in recruiting, onboarding, and helping to build a diverse group of personnel. Finally, Spagnoletti reported on the launch of the D.C. Bar's new Association Management System as well as a new case management system for the Board on Professional Responsibility and the D.C. Office of Disciplinary Counsel.

**The Year Ahead
(Agenda Item 8)**

President Jakovic provided an overview of the year ahead and noted the following: additional training and orientation for Board members, proposed Rule revisions to be recommended to the D.C. Court of Appeals, the appointment of a DEIA Task Force, the work of the Budget Committee that is expected to begin in December 2022, the April Judicial and Bar Conference in collaboration with the D.C. Court of Appeals, and the role of Board members to help nominate and encourage other Bar members to run for the Board in the spring.

CEO Spagnoletti added that the Practice Management Advisory Service's annual Practice 360 program is expected to take place in September 2022 and that a revised Budget Policy and Contracting and Procurement Policy for the D.C. Bar will be presented to the Board for review and approval. Lastly, he noted that a refinancing proposal for the D.C. Bar building may also be brought before the Board for its review.


**Executive Session
